- As SVP of Healthcare Security Operations, led a team of 2,700 security personnel, including 14 directors and 74 managers, across 37 Kaiser Permanente hospitals. Oversaw the delivery of guard services, GSOC operations, incident response, dispatch, threat management, investigations, security tech, contract performance, and client satisfaction. Through process improvement efforts, reduced staffing deficit from 22% to 5% in 8 months during a global staffing crisis, leading to cost savings and restored client trust.

Led enhancements to trauma-informed conflict response training, updated use-of-force policies, and strengthened accountability, resulting in significant improvements to patient and staff safety.

Supported the development of updated design standards, asset and lifecycle management processes, and a business case for a centralized Pharmacy Security Operations Center (PSOC) proposed to integrate over 500 network video recorders and ~30,000 security assets. Efforts led to regulatory compliance and reduced inventory shrinkage.
- As a senior executive strategy consultant, led governance, change management, communications, and execution planning for a national cybersecurity program targeting vulnerabilities in 150,000 network-connected hospital devices. Supported the development of redefined lifecycle processes for security, clinical, and facilities technology; managed project penetration testing efforts; and designed cross-functional risk management processes. The program's efforts led to the creation of a technology risk office that now oversees ongoing cyber and physical risk for Kaiser Permanente.
- As SVP of Healthcare Security Strategy & Business Operations, led the Covid-19 emergency response for 3,000 contract healthcare security personnel, including recruiting and onboarding 600 staff in three months to support hospital access protocols. Directed vaccine mandate compliance, ensuring full workforce adherence by required deadlines. Designed and executed a 3-day induction event to hire, onboard, and health-screen 170 officers to meet the sudden rising hospital demand.

Improved the ability to leverage data for application development by streamlining access to consolidated data lakes, warehouses, operational data stores, and data marts following a major merger.
- As a strategy and program management consultant, led a \$10M public safety initiative with Oakland's top employers (including PG&E), law enforcement, and local government. Launched a police officer overtime and security guard program across 83 downtown blocks, improving coordination and communication—resulting in a 55% year-over-year reduction in crime.

Supported the design of the department's operating model and led program management and governance processes aligned with company lean principles to drive cross-functional collaboration, transparency, and execution.
